

POWERLESS

When I went to my first meeting at age 21, I wasn't powerless over anything. Certainly not alcohol. When I went to my second meeting, seven years later, I still wasn't powerless over anything; but in the hospital I could admit that maybe my life was a little bit unmanageable. As I left the hospital they told me to go to a lot of meetings; not 90 meetings in 90 days, they didn't put on any limits.

Strangely enough, I did what I was told. We say the only requirement for membership is a desire to stop drinking. I had that; but not in the way you might think. You see, I only wanted to stay straight long enough to get together a grand (\$1,000) so I could go out and get really drunk. So I went to a lot of meetings. Most of them at the Twelve Step House in Chicago, a number of people thought I was a resident.

It was difficult during those first months. I remember many days going home on the bus; saying I wouldn't go to the joint at Kedzie, I'll wait till California, then Western, then Devon. One day at a time for me became bus stop to bus stop. But I still wasn't powerless over alcohol, and my life was becoming more manageable. The meetings helped a lot, they gave me some place to go besides the bars. My wife complained about that. I wasn't out drinking; but I was always out at meetings. I told her if she didn't go to Alanon, I was going to leave. She went.

Somewhere around nine months to a year sober, I realized I had the \$1,000 that had been my goal. I had a decision to make. I decided to go to another meeting. That was one meeting too many. I never went out; I have never been able to put together a grand since.

So here I am, eight or nine years after my first meeting, and I'm still NOT POWERLESS OVER ALCOHOL. That came after more meetings.
